2019/20 REVIEW:

2019/20 was challenging for everyone. Prior to March, Council delivered many of its scheduled projects as set out in the 2019/20 Annual Business Plan and Budget. These included the completion of the Hermit Street Nature Play Space, family friendly public toilets on Richardson Place, Lions Park upgrade, the commencement of the timber bollard replacement program, various scheduled footpath, road and walkway works and continuation of the upgrade of street lighting to more energy efficient and longer life LED lights.

The COVID-19 pandemic created a unique set of circumstances. Fortunately, Roxby Downs, to date, has escaped the worst of the impact of the virus, both in a health sense and an economic sense.

2020/21:

The Draft Annual Business Plan and Budget for 2020/21 is responsible and considered. Importantly, Council's response to COVID-19 will be appropriately measured. It will seek to ensure adequate local stimulus without creating any avoidable cost or rating burdens. Council will continue to be debt-free, being able to take advantage from our strong balance sheet. In terms of capital projects, we will continue the important theme of the last couple of years of investing in asset renewal. Council's obligation to deliver essential services to the town forms the focus of our planned capital expenditure for 2020/21.

2020/21 is the fifth consecutive financial year in which Council has endorsed no increase in overall rates for Roxby Downs.

ABOUT YOUR RATES:

Rates modelling for 2020/21 began with an assumption of no rates increase (nominally) as a total and within each category. Using the property valuations provided by the Valuer General dated 7 June 2020, the modelling resulted in the following differential rates.

PROPERTY TYPE - differential rate as cents in the dollar

Residential - 0.54244 cents in the dollar Commercial Shop - 1.58312 cents in the dollar Commercial Office - 2.15213 cents in the dollar Commercial Other - 1.74566 cents in the dollar Industrial Light - 1.33873 cents in the dollar Industrial Other - 1.36243 cents in the dollar Vacant - 1.54390 cents in the dollar Other - 0.94779 cents in the dollar

Fixed Charge of \$680.00 per annum

0% RATES CAPPING REBATE 2020/21:

Due to significant movements in the underlying property valuations that feed into the calculated rates for individual properties, many properties have seen increases compared to last year. Council has resolved to negate these increases by way of a <u>0% Rates Capping Rebate</u>. With the exception of properties subject to a change in rating code, the rating methodology adopted will ensure that no ratepayer will be charged more for Rates in 2020/21 than they were in 2019/20.

SERVICE CHARGE (DOMESTIC WASTE COLLECTION):

\$466.00 per annum - applied to Residential category property types only.

REGIONAL LANDSCAPE LEVY:

Formerly NRM levy. This is a State tax collected by Local Government - the seperate fixed charge for each rateable property is \$64.85 per annum.

RATE PAYMENT DATES FOR 2020/21:

Payment of rates can be made in full by 15 September 2020 or by four (4) instalments on:

- 15 September 2020
- 15 December 2020

- 15 March 2021
- 15 June 2021

UTILITY TARIFFS AND CHARGES:

The Roxby Downs (Indenture Ratification) Act 1982 requires Council to supply residents of Roxby Downs with electricity, water and sewerage services. Charges (tariffs) for these utilities are reviewed each year in July.

There will be no increase in Roxby Power and Water tariffs and supply charges for 2020/21.
